"Uzmeliomashleasing" state leasing company was founded on the basis of the Resolution of the Cabinet of Ministers of the Republic of Uzbekistan dated December 21, 2007 No. 266 "Uzmeliomashleasing" on the establishment of the state leasing company. to provide water management construction and exploitation organizations, as well as water user associations and farms for the purpose of lease of land reclamation machinery, machinery and other mechanization means purchased by them upon their instruction, engaged in land reclamation activities of irrigated lands is specified.

Resolution of the Cabinet of Ministers of the Republic of Uzbekistan from May 7, 2008 of No. 92 "About measures for the organization and establishment of the state unitary enterprises specializing on melioration and other water economy" 48 state unitary enterprises and irrigated land reclamation facilities were provided with modern melioration equipment.

The main function of the company is to ensure leasing delivery of modern melioration and other machinery, machinery and equipment with the objective of updating the equipment base of the undertakings irrespective of the form of ownership. At the same time, the main priority is focused on

water-reclamation and use organizations engaged in irrigated land reclamation activities and other water management activities.

The subsidiary of Meliomashlizingsservice was founded under the post of the Cabinet of Ministers of the Republic of Uzbekistan № 01-03-40 under the "Uzmeliomashlizing" state leasing company. Its main purpose is to provide technical maintenance of agricultural, meliorative equipment and machinery leased to enterprises under the Ministry of Agriculture and Water Resources.
